DIRECTIONS FOR USE

- Shake well before each use. For maximum performance, apply at recommended rates followed by a light irrigation to move product into the root zone.
- Keep container closed when not in use.
- Mix in spray tanks with water and agitation.
- May require addition of a defoamer.

RECOMMENDED RATES

| Situation | Rate per 100m ² | Rate per hectare | Comments |
|---|----------------------------|------------------|---|
| Preventative application of localised dry spot in sportsfields and fairways | 250-500mL | 25-50L | Apply in no less than 400L/ha of water. Irrigation is not critical but is recommended to ensure product effectiveness. Repeat treatments at the desired application frequency. |
| Preventative application of localised dry spot in greens and tees | 200-400mL | 20-40L | Apply in no less than 400L/ha of water. Irrigation is not critical but is recommended to ensure product effectiveness. Repeat treatments at the desired application frequency. |
| Curative application of localised dry spot (green, tees, fairways and sportsfields) | 400-500mL | 40-50L | Apply in no less than 400L/ha of water. Irrigation is not critical but is recommended to ensure rapid hydration of the profile. Repeat applications fortnightly and continue as required until recovery occurs. |
| Ornamental garden beds & landscaped areas | 15mL per 10L of water | | Sufficient to drench area of up to 5m ² . Water in well following application. Apply as necessary. |
| Horticulture (General Use) | 150mL per 100L of water | | Apply around base of plants or tree and water in well following application. Apply as necessary. |
