APPLICATION

Either apply Alzon 46 as a single application at the start of vegetation OR if split, 50-60% at start of vegetation and 40-50% as late application brought early.

FERTIGATION

ALZON 46 is highly soluble and can be fertigated onto crops however is not suitable for foliar application.

BLENDING

ALZON 46 is ideally suited for blending in bulk-fertiliser mixes.
